TYPE OF ORGANIZATION:

First of all, what the organization is not about. We are not about being conservatives. We are not a group of liberals. We are not republicans, nor are we democrats, or libertarians. We do welcome all of the above in our organization, and we will not try to change you. Be any of the above, and remain so, but just be in favor of, and work with us for, liberty.

The word “constitution” means what something consists of, what it is. So, the Constitution of the United States is what America is. We love America. We love liberty, and absolutely, and without reservation, we do not tolerate slavery, or the road leading to it. Left vs right are for some other discussion. This is about Liberty vs Slavery. GOALS:

Our goal is liberty for the people by way of the Tenth Amendment of the U.S. Constitution, for the State of Colorado and Huerfano County. The Tenth Amendment of the U.S. Constitution reads, *The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the States respectively, or to the people.* Although the wording designates “States,” counties have gained independence through the actions of Sheriffs, and written declarations of independence from the unconstitutional U.S. so-called “Patriot” Act.

METHODS:

We do not sit at meetings and get all worked up about liberty, then go home and watch TV to forget about it. We meet, and then work. Some of the founders of our great nation gave their blood for our liberty. We must give our shoe leather, invest money to print flyers, and time to give them out. Start immediately with this flyer, copy and distribute. For the able bodied, just sitting at a telephone, or a computer, is not enough. We must confront our County Commissioners in chambers after obtaining an appointment. We must coordinate with our Sheriff. We must get petitions signed. We must help with the state actions.
